Across 2 inspections since 2024, the issues cited most often were Bed, Cribs, Playpens, Cots or Mats Were Not Placed at Least 18" Apart or Separated by Partitions When in Use. (1), The EMC Plan Was Not Reviewed with All Staff Annually and Whenever the Plan Was Revised. (1), and Each Employee's Personnel File Did Not Contain an Annual Staff Evaluation and a Staff Development Plan. (1). None of the 5 findings were critical.

- **Bed, Cribs, Playpens, Cots or Mats Were Not Placed at Least 18" Apart or Separated by Partitions When in Use.**

The cots in space #3 were not placed at least 18" apart or separated by partitions when in use. Violation confirmed corrected by letter received from provider on 1/17/2025

- **The EMC Plan Was Not Reviewed with All Staff Annually and Whenever the Plan Was Revised.**

There was no documentation on file for all staff showing an annual review of the EMC was completed. Violation confirmed corrected by letter received from provider on 1/17/2025

- **Each Employee's Personnel File Did Not Contain an Annual Staff Evaluation and a Staff Development Plan.**

An annual staff evaluation and staff development plan were not on file for all staff. Violation confirmed corrected by letter received from provider on 1/17/2025

- **All Staff Did Not Review the Center's EPR Plan During Orientation And/or on an Annual Basis with the Trained Staff.**

Documentation of an annual EPR Plan review was not maintained on file for all staff. Violation confirmed corrected by letter received from provider on 1/17/2025
