(1), Staff Did Not Wash Their Hands Thoroughly Before Beginning Work, Before/after Handling Food, Before Bottle Feeding or Serving to Other Children, After... (1), and Crib Sheets Were Not Changed as Needed or at Least Daily. (1). None of the 5 findings were critical.

● **Staff Did Not Wash Their Hands Thoroughly Before Beginning Work, Before/after Handling Food, Before Bottle Feeding or Serving to Other Children, After...**

● **Crib Sheets Were Not Changed as Needed or at Least Daily.**

Space #4, a child was observed stepping on a cot and then falling onto the cot. Violation corrected during visit

● **A Safe Indoor and Outdoor Environment Was Not Provided for the Children.**

Outdoors, I observe the anchors for the green metal jeep was exposed causing a tripping hazard. One (1) red plastic storage container was observed broken with sharp edges. Violation confirmed corrected by letter
