An outdoor playground inspection was not completed for the month of January 2025. Violation confirmed corrected by letter received from provide
- **Each New Employee Did Not Complete, Within the First Two Weeks of Employment, Six Clock Hours of Training in Required Topic Areas.**  
Staff member, T.G. did not receive the required six hours of orientation within the first two weeks of employment. Violation confirmed corrected by lette
- **Shelter-in-place or Lockdown Drills Were Not Practiced Every Three Months And/or Drill Record Was Incomplete.**
