● **Operator or Other Transportation Provider Did Not Have Written Permission From Each Child's Parents or Guardian to Transport the Child.**

All children need an updated permission to transport and leave the premises form. Violation confirmed corrected by letter received from provider on 3

● **Operator Did Not Complete the Required Number of On-going Training Hours as Specified in Rule.**

The Provider completed 2 out of 10 on-going training hours. Proof of 8 training hours must be completed and copies of the certificates submitted to me by March 18, 2025. Violation confirmed

● **Written Feeding Schedule Was Not on File for Each Child Under 15 Months of Age And/or Was Not Updated Regularly to Reflect Changes in the Child's Needs.**

One 11 month old child was missing a feeding schedule. Violation confirmed corrected by letter received from provider on 10/13/2023
