Across 2 inspections since 2026, the issues cited most often were Children Were Not Adequately Supervised at All Times. (1), All Walls and Ceilings Including Doors and Windows Were Not Kept Clean, Free of Visible Fungal Growth, and in Good Repair. (1), and Fire Drills Were Not Practiced Monthly And/or the Drill Record Was Incomplete. (1). None of the 5 findings were critical.

● **Children Were Not Adequately Supervised at All Times.**

On February 12, 2026, a two year old child was left unsupervised in a classroom for approximately two minutes. Violation confirmed corrected by letter received from provider on 2/13/2026

Feb 9, 2026 4 Findings ● 4 Important

● **All Walls and Ceilings Including Doors and Windows Were Not Kept Clean, Free of Visible Fungal Growth, and in Good Repair.**

In a few classrooms throughout the building, I observed peeling paint on the walls. Violation confirmed corrected by letter received from provider on 2/23/2026

● **Fire Drills Were Not Practiced Monthly And/or the Drill Record Was Incomplete.**

The center did not have documentation of completing a monthly fire drill for January 2026. Violation confirmed corrected by letter received from provider on 2/23/2026

● **All Corrosive Agents, Pesticides, Bleaches, Detergents, Cleansers, Polishes, Any Product Which Is Under Pressure in an Aerosol Dispenser, and Any Substance...**
