Across 2 inspections since 2025, the issues cited most often were Electrical Outlets and Power Strips, Not in Use, Which Were Located in Space Used by Children Did Not Have Safety Outlets or Were Not Covered with Safety Plugs... (1), All Corrosive Agents, Pesticides, Bleaches, Detergents, Cleansers, Polishes, Any Product Which Is Under Pressure in an Aerosol Dispenser, and Any Substance... (1), and Prior to the Expiration Date of the Qualification Letter, the Child Care Provider Did Not Complete and Submit Required Forms to Complete a Criminal Background... (1). None of the 5 findings were critical.

- **Electrical Outlets and Power Strips, Not in Use, Which Were Located in Space Used by Children Did Not Have Safety Outlets or Were Not Covered with Safety Plugs...**  
unless located behind furniture or equipment that cannot be moved by a child. In space #4, I observed a multiple outlet plug
- **All Corrosive Agents, Pesticides, Bleaches, Detergents, Cleansers, Polishes, Any Product Which Is Under Pressure in an Aerosol Dispenser, and Any Substance...**  
which may be hazardous to a child if ingested, inhaled, or handled were not stored in a locked room or cabinet. In two (2) vehicl
- **Prior to the Expiration Date of the Qualification Letter, the Child Care Provider Did Not Complete and Submit Required Forms to Complete a Criminal Background...**  
check (a qualification letter is valid for a maximum of five years for the date of issuance).One (1) file had an expired quali

- **All Equipment and Furnishings Were Not in Good Repair.**  
On the 2's playground, there were three (3) seat swings in need or repair/replacement, the strap's were missing the clasp, entire strap or were too short. Violation confirmed corrected by letter received from provider on 1/5/2026
