(1), New Staff, Who Had Contact with Children, Did Not Receive at Least 16 Hrs. Orientation Within First 6 Weeks. (1), and All Staff Did Not Successfully Complete Certification in First Aid Appropriate to the Age of Children in Care. (1). None of the 5 findings were critical.

● **Menus for All Meals and Snacks Were Not Current or Posted Where Easily Seen by Parents and Cook.**

A menu was not posted in the kitchen to be easily seen by food preparation staff. The menu posted for parents was not dated. Violation confirmed corrected by letter received from provider

● **New Staff, Who Had Contact with Children, Did Not Receive at Least 16 Hrs. Orientation Within First 6 Weeks.**

Orientation was not documented for a staff member hired on 11/24/25 and a staff member hired on 12/1/25. Violation confirmed corrected by letter received from provider on 3/23/

● **All Staff Did Not Successfully Complete Certification in First Aid Appropriate to the Age of Children in Care.**

Verification of staff completion of First Aid training from an approved training organization was not in the staff file. First Aid certification expired in February 2026 for

● **All Staff Did Not Successfully Complete Certification in CPR Training Appropriate to the Age of the Children in Care.**

Verification of staff completion of the CPR course from an approved training organization was not in the staff file. CPR certification expired in February 2026 for two

● **A Child Care Operator Did Not Notify the Division of Any New Child Care Providers, as Defined in G.S. 110-90.2(a)(2), Who Were Hired or Moved Into the Child...**

care facility within five business days. This is a repeat violation from 10/2/25. Violation confirmed corrected by letter receiv
