Across 3 inspections since 2026, the issues cited most often were A Safe Indoor and Outdoor Environment Was Not Provided for the Children. (2), All Group Leaders Were Not at Least 18 Years of Age, Have a High School Diploma, And/or Had Not Completed Basic School Age Care (BSAC) Training. (1), and Equipment and Furnishings Were Not Sturdy, Stable and Free of Hazards. (1). None of the 5 findings were critical.

When a child was sliding down from the top of the slide, the child's braid with beads was caught and detached. Violation confirmed corrected by letter received from provider on 5/21/2026

Mar 5, 2026 1 Finding ● 1 Important

● **A Safe Indoor and Outdoor Environment Was Not Provided for the Children.**

A teacher opened the kitchen door and when it closed a child's fingers were caught in the door which resulted in a broken finger and two fingernails being removed. Violation confirmed corrected by follow-up visit

Jan 30, 2026 3 Findings ● 3 Important

● **All Group Leaders Were Not at Least 18 Years of Age, Have a High School Diploma, And/or Had Not Completed Basic School Age Care (BSAC) Training.**

One group leader had not completed the BSAC training within three(3) months of hire. Violation confirmed corrected by letter received from
