Across 4 inspections since 2023, the issues cited most often were A Safe Indoor and Outdoor Environment Was Not Provided for the Children. (2), The Written Feeding Plan Was Not Modified as the Child's Needs Changed. (1), and Application Did Not Include the Names of Individuals to Whom the Center May Release the Child, as Authorized by the Person Who Signs the Application. (1). None of the 5 findings were critical.

● **The Written Feeding Plan Was Not Modified as the Child's Needs Changed.**

The feeding plan for one child was not modified to reflect the changes in feeding. Violation confirmed corrected by letter received from provider on 9/16/2025

● **Application Did Not Include the Names of Individuals to Whom the Center May Release the Child, as Authorized by the Person Who Signs the Application.**

One child's application did not list an individual other than the parent. Violation confirmed corrected by letter received from provide

Feb 25, 2025 1 Finding ● 1 Important

● **Caregivers Did Not Document Compliance with Visually Checking on Sleeping Infants Aged 12 Months or Younger And/or the Documents Were Not Maintained for A...**

minimum of one month. The safe sleep checks were not completed from February 1-18, 2025. Violation confirmed corrected by letter

Mar 19, 2024 1 Finding ● 1 Important

● **A Safe Indoor and Outdoor Environment Was Not Provided for the Children.**

Two pickets on porch area of storage building in fenced-in space were unattached, leaving exposed nails accessible to the children. Violation confirmed corrected by letter received from provider on 3/20/2024
