Across 3 inspections since 2025, the issues cited most often were A Safe Indoor and Outdoor Environment Was Not Provided for the Children. (1), Medication Authorization, Giving the Caregiver Standing Authorization Did Not Meet the Specifications in Rule. (1), and On or Before the First Day of Work, All Staff, Including the Director and Individuals Who Volunteer More Than Once per Week Did Not Provide Results Indicating... (1). None of the 5 findings were critical.

In the space for toddler age children a large pair of "teacher" scissors and a hanging cord for a music speaker was observed accessible to the children. Violation corrected during visit

The provider did not have six month permission on file to administer emergency medication to children enrolled with emergency medication. Violation confirmed corrected by le
