in a residence). Two toddlers (under the age of 15 months) in classroom space #2 did not have a feeding schedule.

- **The EMC Plan Was Not Reviewed with All Staff Annually and Whenever the Plan Was revised.It Could Not Be Verified That the Two Staff, Who Began Employment In...**  
August 2025, had reviewed the Emergency Medical Care Plan. Violation confirmed corrected by letter received from provider on 1/2
- **New Staff, Who Had Contact with Children, Did Not Receive at Least 16 Hrs. Orientation Within First 6 Weeks.**  
There was no documentation on file that the two staff, who began employment in August 2025, had received new staff orientation. Violation confirmed corrected by letter received
- **Staff Required to Receive On-going Training Had Not Completed the Required Number of Hours According to Their Education and Experience.**  
The staff/training worksheet was submitted to the consultant with the Corrective Action letter for the 1/13/26 Annual Compliance visit. After review
