(1), Each Child Was Not Attended to in a Nurturing and Appropriate Manner, or in Keeping with the Child's Developmental Needs. (1), and A Child Was Handled in a Rough Way, Including Shaking, Pushing, Shoving, Pinching, Slapping, Biting, Kicking, or Spanking. (1). None of the 5 findings were critical.

A staff member grabbed a child by their upper arm, pulled the child to them, and sat the child down while still holding on to the child. A staff member used their
