Findings: During the inspection, it was determined the water temperature was 138 Degrees Fahrenheit in the program restroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit.

4. The posted chart was not displayed in the size available in the ODJFS forms central to be easily read.
