Rule: 5180:2-13-11 Outdoor Space

Code: The program staff is required to protect the children from hazardous conditions in the outdoor play area.

Findings: During the inspection, it was determined that the following hazardous conditions existed in the outdoor play area, as noted in number 15 below:

15. Other [Dog feces on the outdoor play area].

Rule: 5180:2-13-11 Fall Zone

Code: The program is required to use fall surface material according to manufacturer's guidelines and provide fall zones around equipment to prevent injury if a child were to fall.

Findings: During the inspection, it was determined the fall zone under and around equipment designated for climbing, swinging, balancing and sliding did not meet the requirements as noted in number 1 below: There is a large and deep hole in the gravel that is a fall hazard for the children. It appears to be a possible sink hole or animal burrowing hole. The ground around it appears to be starting to cave a bit as well.

1. The fall surface material had not been properly distributed, turned over or raked as needed.

Corrective Action Plan Due: 06/07/2026

Domain: 04 Indoor/Outdoor Space

Rule: 5180:2-13-12 Safe Equipment

Code: The program is required to use equipment that is safe and hazard free according to the manufacturer's guidelines. Fans, air conditioners, heat pumps, and space heaters must be inaccessible to children. The program is required to refrain from using trampolines, ball pits and inflatable equipment intended for climbing and bouncing, including but not limited to slides and bounce houses.

Findings: During the inspection, equipment was determined to be unsafe, hazardous to children, or in need of repair as noted in number 7 below: There is a large nail and a hook protruding from the ground in the outdoor play area.

7. The equipment had protruding nails.

Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
