Across 1 inspection since 2025, the issues cited most often were The Licensee Was Out of Compliance with R430-90-13(4) by Having Choking Hazards Accessible to Children Younger Than 3 Years of Age. In the Storage Bins, There Were Several Small Choking Hazards. (2), The Licensee Was Out of Compliance with R430-90-14(4) by Not Conducting Required Drills. At the Time of the Inspection, There Was Not a Fire Drill Conducted in the Last Quarter. This Was a Repeat Rule Noncompliance as Noted on 03/07/2023. (1), and The Licensee Was Out of Compliance with R430-90-8(2)(a)-(d) by Not Submitting an Online Background Check Form and Fingerprints for a Caregiver. At the Time of the Inspection, There Was One Caregiver Who Did Not Have a Background Check or Fingerprints Submitted. (1). None of the 5 findings were critical.
