At the Time of Inspection, One Household Member Submitted a Background Form, but Has Not Submitted Fingerp (2) and The Provider Was Out of Compliance with This Rule by Not Having Required Forms for Each Child Enrolled. At the Time of the Inspection, One Child Did Not Have an Admission Form or Health Assessment. This Was a Repeat Rule Noncompliance. (1). None of the 3 findings were critical.
