Under the Sink and in a Teacher's Desk Drawer in a Classroom, There Were Accessible Cleaners. This Is a Repeat Non Compliance. (1), and The Provider Was Out of Compliance with This Requirement by Having an Accessible Medication. In a Teacher Desk Drawer, There Were Over the Counter Supplements. This Is a Repeat Non Compliance. (1). None of the 4 findings were critical.
