An item marked keep out of the reach of children was accessible when a shampoo was stored in an unlocked cabinet.

● **Current Authorizations For Medications On Premises**

A medication not intended for use by children, was stored at the center, without a valid authorization for its administration.

● **Adult Handwashing**

A staff did not wash her hand after cleaning a child's runny nose.

● **Infant & Toddler - Soft Materials In Cribs**

An infant was observed sleeping in a crib on a boppy pillow, covered with a blanket and wearing a pacifier strap.

● **Infant & Toddler - Diaper Changing Surface Disinfection**

The diapering changing pad at the infants room was covered with a sheet and paper towel making it difficult to disinfect.
