Across 7 inspections since 2024, the issues cited most often were Outdoor Play Space - Energy-Absorbing Surfaces (10), Medical Log - Pages & Entries (6), and Infant & Toddler - Documenting Changes In Development (5). None of the 30 findings were critical.

● **Child Tracking Procedure**

The center's child tracking procedure was not accurate on 04/01/26, when 6 children were present in the Infant 2 classro

● **Outdoor Play Space - Energy-Absorbing Surfaces**

251.06(11)(b)5.

The energy-absorbing surface (mulch/wood chips) was observed to not be at a depth of at least nine inches underneath a s

● **Outdoor Play Space - Enclosure**

251.06(11)(b)7.

There is a gap greater than 4 inches underneath the fence which makes up the outdoor play space enclosure.

● **Potential Source Of Harm On Premises**

Several pacifiers with rubber and hard beads attached were observed in the Infant 1 classroom. These beads pose a poten

● **Fire Alarms & Smoke Detectors - Testing**

Fire alarm testing was not documented for February-March 2026.

On 03/31/26 incorrect breast milk was given to a child in the Infant 1 classroom.

● **Staff Record - Days & Hours Worked**

251.05(2)(a)6.

Documentation of staff hours worked and in which classroom was not accurate for the Toddle 2 room or the Toddler 1 room.

● **Infant & Toddler - Food & Formula Brought From Home**

251.09(3)(a)2.

In the infant 2 room a container of infant formula didn't contain a label with a date.

● **Infant & Toddler - Correct Food, Breastmilk, Or Formula**

251.09(3)(a)2m.

An infant was accidently feed incorrect breastmilk

Aug 26, 2025 6 Findings ● 6 Important

● **Health, Safety & Welfare Of Children**

251.04(2)(m)

A child was assisted off the the floor by their hands and not under their arms causing a nurse maid elbow injury on 8/12

● **Health, Safety & Welfare Of Children**

Children were allowed to sit on the outside of a tube slide and a 6 year old child fell off the slide causing the child

● **Supervision Of Children**

251.055(1)(a)

Staff failed to guide children's behavior and ensure safety when children were allowed to climb on the outside of a circ

● **Child Tracking Procedure**

251.055(1)(f)

The tracking procedure was not properly implemented in the Infant 2 room as 6 children were listed on the tracking, but

● **Washrooms - Sanitary Conditions**

Urine was observed in an unflushed toilet.
